SECTION 4: First-Aid Measures

4.1. General First Aid Information

4.2. Most Important Symptoms and Effects, Acute and Delayed

If ingested, dilute with water and call a physician. DO NOT INDUCE vomiting. For eyes, flush out with plenty of water at least 15 minutes. Call a physician. Reacts violently with acids. 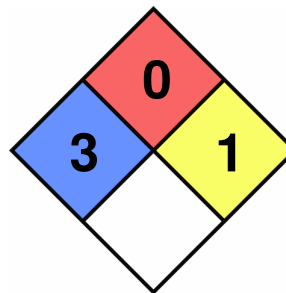
